

Date rules were last amended: 04 November 2020.

Please read these competition rules carefully. These competition rules (“rules”) explain your rights and duties under this competition. If you take part in this competition or accept any prize, these rules will apply to you and you agree that the person running the competition (“the promoter/s” or “FNB”) can assume that you have read and agreed to be legally bound by these competition rules.

1. The FNB Swipe and Win Competition (“Competition”) is organised and conducted by First National Bank Zambia Limited (“FNB”).
2. The Competition will run from 6 November at 09:00 hours and will strictly close on 5 February 2021 at 23:59PM. Transactions made after the closing date will not be considered by FNB.

WHO CAN PARTICIPATE?

3. The Competition is open to all FNB Zambia customers that are in good standing and entrants must be in possession of a valid NRC or Passport.
4. Participants who are directors, members, partners, employees, agents of or consultants of FNB, its subsidiaries, holding companies, divisions and/or associated companies or of the advertising or promotion agencies or any other person who directly or indirectly controls or is controlled by FNB, will not qualify to participate in the Competition and will also not be eligible for any prizes.
5. By entering this Competition, all participants agree to be bound by these terms and conditions, and FNB’s decision regarding any issue with the Competition will be final and binding and no correspondence will be entered into.

HOW TO QUALIFY?

6. To qualify, participants need to swipe with their FNB Visa debit card
7. Participants must swipe their FNB Visa debit or credit card a specified number of times in order to qualify for the draw.
8. Winners will be determined based on meeting the minimum number of unique qualifying card swipes during the Competition period.
9. FNB does not accept any responsibility for any transaction that is not delivered, received or is delayed or damaged due to technical reasons, including telecommunication failure on the part of the participant’s service provider, or otherwise.
10. Participants acknowledge and agree that they may incur costs or other charges ordinarily associated with using an FNB Visa debit card.

PRIZES

11. The prizes consist of the following: Groceries for one month and the grand prize of groceries for a year.
12. There will be 3 draws. The first and second draws will each consist of 10 winners of one month's worth of groceries and the final draw will consist of 2 winners of the grand prize totalling 22 winners over the period. The value of the groceries in question will be capped at ZMW 4,000 per winner in the monthly prize category and ZMW 3,500 for the grand prize category.
13. The grand prize of groceries for one year will be staggered over a 12-month period.

16. Winners will be announced by call or SMS within 48 hours of the draw.
17. The prizes do not cover any other costs of the winner whatsoever.
18. Cash conversions will not be permitted.
19. FNB reserves the right to substitute the prizes for an alternative prize of equal or greater value should the prizes promoted not be available due to unforeseen circumstances.
20. FNB will not be liable for any loss suffered as a result of incomplete or incorrect information provided.
21. FNB reserves the right to withhold prizes in the event that it reasonably believes, in its sole discretion, that the winner is not eligible to win, has contravened any of these terms and conditions, has acted in a manner that is not in the spirit of the Competition, their conduct can be reasonably interpreted as scamming or circumventing the rules of the Competition, acted fraudulently with regards to the Competition, if it would be unlawful to award the prize. In this instance the winner will be disqualified and forfeit the prize. FNB's decision shall be final and no correspondence will be entered into.

PUBLICITY AND DATA PRIVACY

22. By entering the Competition, a participant acknowledges that personal information about him/her will be shared with FNB and their agents to the extent necessary to conduct the Competition.
23. The prize winner must accept that his/her name and/or likeness may be announced in FNB's media publications or on the Internet for publicity or advertising purposes without additional compensation, except where prohibited by law.

GENERAL

24. FNB reserves the right to shorten, extend, suspend the time period of the Competition or terminate the Competition whenever it should so choose for technical, commercial, or operational reasons, or for reasons beyond its control or generally for any reason whatsoever within their sole discretion. The Competition, its prizes, and terms and conditions may be amended by FNB, at any time during the Competition, and will be applied and interpreted within its sole discretion. In such an event, all participants waive any rights that they may have/purport to have in terms of this Competition and acknowledge that they will have no recourse against FNB whatsoever.
25. All publicity and other materials will be the sole property of FNB.

26. FNB is not liable for any technical failures affecting participation in the campaign and they assume no liability in this regard.
27. To the fullest extent permitted by law, by participating, the participant indemnifies, releases and agrees to hold harmless FNB, their associated, holding and subsidiary companies, and its directors, officers, agents, representatives, shareholders, employees, successors and assigns from any and all claims or liability arising from participating in the Competition, any Competition-related activity and/or acceptance, receipt, possession or use/misuse of any prize.
28. To the extent permitted by law, FNB will not be liable in any way whatsoever, for any claims arising from loss, injury, damage or costs, suffered by a participant in relation to this Competition or the prizes offered, including but not limited to claims relating to defects in the prizes or any losses caused by such defects or losses arising from incorrect or inaccurate information supplied by participants.
29. FNB will not be liable for any loss suffered as a result of incomplete or incorrect information provided.
30. Zambian law shall govern these competition terms and conditions and the courts of Zambia shall have exclusive jurisdiction.

IMPORTANT:

- **You agree to indemnify the promoter(s) fully for any loss or damage the promoter(s) may suffer because you breached the competition rules. This means you agree to reimburse the promoter(s) for the following: any loss or damage they suffer, any expenses and costs they paid or are responsible for. Legal costs mean costs on an attorney and own client scale.**
