

FNB Zambia VISA Spend, Earn Cashback and Win Campaign Terms and Conditions

Competition Overview

These terms and conditions outline your rights and obligations when participating in the FNB Zambia VISA Campaign. By participating or accepting any prize, you agree to be bound by these rules.

Campaign Prizes

Mechanics:

1. Make international or local payments using the FNB VISA Card totaling ZMW2,000+ in a month to enter the Monthly Draw.

Earn extra entries for every additional ZMW2,000 spent.

 Make international or local payments totaling ZMW5,000+ in a month to enter the Grand Prize Draw.
For payments for even additional ZMWE 000 energy

Earn extra entries for every additional ZMW5,000 spent.

Note: International transactions of K5,000+ will earn you two entries into the grand draw.
